Changes to system requirements

Use of specific fonts in Web-to-Publish

With the transmission of font files and commissioning for the installation, you transfer the license rights to BrandMaker. In case of missing evidence, BrandMaker can refuse the installation of the font or delete already installed fonts without further explanation and announcement.

SSL certificate for custom domains

If you use a customer-specific domain (URL), you are required to provide the corresponding SSL certificates according to the requirements set by BrandMaker. Both the customer-specific domain and the SSL certificate result in additional and recurring costs.

To ensure the security and functionality of your system, BrandMaker can request replacement from you according to the current security requirements.
